

Valná hromada společnosti ČEZ, a.s., dne 23.4.2007 schválila, že společnost může počínaje dnem konání této valné hromady nabýt vlastní kmenové akcie celkem v objemu, který nepřekročí 59 221 084 kusů s tím, že nejnižší cena, za kterou může společnost své akcie nabýt, činí 300 Kč za akcii, a nejvyšší cena, za kterou může společnost své akcie nabýt, činí 2 000 Kč za akcii. Doba platnosti tohoto usnesení činí 18 měsíců a nabyté vlastní akcie může společnost použít ke snížení základního kapitálu společnosti, či ke splnění závazků, vyplývajících z akciových opčních programů, a to do výše 5 milionů kusů. Důvodem pro realizaci zpětného odkupu akcií je současná neefektivní struktura kapitálu a nevyhovující poměr vlastního kapitálu a dluhu společnosti. Načasování realizace zpětného odkupu bylo též ovlivněno rozhodnutím vlády ČR ze dne 19. 3. 2007 o prodeji části akcií společnosti ČEZ prostřednictvím kapitálového trhu. V návaznosti na usnesení valné hromady rozhodlo představenstvo společnosti dne 25.4.2007 zahájit program zpětného odkupu vlastních akcií a souhlas vyslovila i dozorčí rada společnosti dne 27.4.2007.

The General Meeting approved that the CEZ company may acquire own equity shares as from April 23, 2007 in the quantity, which does not exceed 59,221,084 pieces in total. The lowest price, at which the CEZ company shall be allowed to acquire its shares, is CZK 300,- per share. The highest price, at which the company shall be allowed to acquire its shares, is CZK 2,000,- per share. The validity term of this decision is 18 months and the acquired shares can be used by the company for reduction of the equity capital of the company, or for fulfilling the commitments arising from the joint-stock option programs namely within the amount of 5 million pieces. The reason for the realization of the share-buy-back program is the current ineffective structure of the capital and the unsatisfactory debt-to-equity ratio of the company. Timing of the realization of the share-buy-back program was also affected by the decision of the Government of the Czech Republic of March 19, 2007 concerning the sale of part of the ČEZ company's shares through the capital market. Further to the resolution of the General Meeting, the Board of Directors decided to commence the share-buy-back program on April 25, 2007 and this was approved by the Board of Supervisors of the ČEZ company on April 27, 2007 as well.

Walne zgromadzenie zatwierdziło, że spółka ČEZ może od dnia 23 kwietnia 2007 nabywać własne akcje podstawowe w ilości, która łącznie nie przekroczy 59 221 084 sztuk. Najniższa cena, za którą może spółka ČEZ swoje akcje nabyć, wynosi 300 Kč za akcję. Najwyższa cena, za którą może spółka ČEZ swoje akcje nabyć, wynosi 2 000 Kč za akcję. Okres ważności tej uchwały wynosi 18 miesięcy i nabyte akcje własne mogą być przez spółkę użyte do obniżenia kapitału zakładowego spółki, do spełnienia zobowiązań wypływających z akcyjnych programów opcyjnych, a to do wysokości 5 milionów sztuk. Przyczyną realizacji skupu zwrotnego akcji jest obecna nieefektywna struktura kapitału i nieodpowiedni stosunek kapitału własnego i długu spółki. Na nastawienie czasowe realizacji skupu zwrotnego miała także wpływ decyzja rządu RCz z dnia 19. 3. 2007 o sprzedaży części akcji spółki ČEZ za pośrednictwem rynku kapitałowego. W nawiązaniu do uchwały walnego zgromadzenia podjął zarząd decyzję w dniu 25.4.2007 o wszczęciu programu skupu zwrotnego akcji własnych a zgodę wyraziła także rada nadzorcza ČEZ w dniu 27.4.2007.
