The transfers of bonds effected in the course of the day when the Meeting is held are not taken into account.

During the registration, a physical person shall identify herself/himself with an identity card; an authorised person shall moreover submit the original copy of a power of attorney including the authentication of principal's signature. A person acting on behalf of a legal entity shall submit an identity card, the original copy of the certificate of incorporation of the legal entity on whose behalf s/he acts not older than three months (possibly a copy of an entry in a register similar to the Commercial Register in which a foreign legal entity is registered). Moreover, authorised persons shall submit the original copy of a power of attorney including the authentication of principal's signature. The documents submitted by a foreign person must comply with the requirements of legal regulations and international treaties regarding higher authentication, must be translated into Czech and provided with a stamp from a certified translator with the exception of documents in Slovakian.
