Fixing the price of eurobonds

ČEZ, a. s., (A2/A-) successfully fixed the price for the ten-year bond issue worth € 500 million. These notes will be issued within the framework of established EMTN (Euro Medium Term Notes) programme. The deal was priced at a spread of 167 basis points above the reference mid-swap rate with the resulting 4.50 % coupon. The expected issue date is 28 June 2010.
